### IMPORTANT TO REGISTER FOR THE 2024-2025 SCHOOL YEAR:

**PRE-KINDERGARTEN STUDENTS** MUST BE 4 YEARS OLD **BY** SEPTEMBER 30, 2024

**KINDERGARTEN STUDENTS** MUST BE 5 YEARS OLD **BY** SEPTEMBER 30, 2024

### ***New Students – Documents required for registration:***

- ☐ The child's (original) long version birth certificate bearing parents' names
- ☐ A proof of parents' Canadian citizenship (i.e. Birth Certificate *(if born in Canada)* of the parent making the child eligible, or valid passport or Canadian citizenship certificate)
- ☐ The permanent code of the parent making the child eligible will be required to fill-out the certificate of eligibility application *(can be found on report cards & or transcripts)*
- ☐ The child's last report card if attended a school the previous year
- ☐ Two Québec proofs of residency (ex. utility invoices, tax receipt, property taxes, etc.)
- ☐ Social insurance numbers of both parents will be requested for income tax purposes (Relevé 24)
- ☐ The child's vaccination booklet
- ☐ Specialist reports (Psychology, Speech therapist etc.) for students with special needs.
- ☐ For Pre-Kindergarten & Kindergarten students, name and address of child's current daycare will be requested.

### ***A child is eligible if:***

- mother or father is a Canadian citizen who has received the major part of his/her primary school instruction in English in Canada;
- The grandfather or grandmother is a Canadian citizen who has received the major part of his/her primary school instruction in English in Canada;
- The mother or father is a Canadian citizen and their child has received or is receiving primary or secondary instruction in English in Canada and that such education is a major part of his/her education; the siblings of such a child are also eligible for English instruction;
- A child has severe learning disabilities and instruction in English can facilitate the learning process.
